- The meeting was called to order by Chair Sharleta Hall at 6:00 p.m.
- Chair Sharleta Hall led the Moment of Silence.
- Pledge of Allegiance was led by Chair Sharleta Hall.
- A motion was made by Mr. James Steverson to approve the agenda for September 7, 2021 agenda seconded by Mr. Carlton Mahone 4-0-0
- Action Items from Superintendent Dr. James Catrett, Superintendent
- Corona Virus Outbreak Update Mrs. Epps Talbot County has had 22 deaths from Covid with 52 hospitalizations; increase 32 in the last two weeks; 22 in the last week. The threat level is still high. Contact tracing is still taking place within the school. Schools are still required to report to the Department of Public Health Covid cases.
- Virtual Option vs. Total Virtual Mr. Taylor Our online platform is Odysseyware. It is
 an on-line curriculum for students in grades 3 12. It is student paced, mastery based,
 teacher interactive online. Teachers will be placed at certain times to assist students with
 questions/problems. Until your grade level modules are completed, you cannot move
 forward. Only five parents have come and signed their children up for total virtual
- Suicide Prevention Dr. Tarleton A suicide packet was presented to the board members. In the folder a Georgia Crisis & Access Line was provided along with National Suicide Prevention Lifeline number. A mobile crisis team can be sent to an individual's home to provide help. The pamphlet outlines warning signs "having trouble coping" and things to look for as warning signs. Handouts were given showing Risk Factors for Suicide along with Protective Factors. If you hear of someone stating self harm or harm to others we are self-reporters and required to report such behavior. Suicide is the second largest cause of death in teenagers. Males are more likely to use guns where females are more likely to take pills. One in ten high school students attempt suicide.

- Bullying Prevention Dr. Tarleton Bullying Protocol was given to the board members. The Protocol is how bullying is handled here at Talbot County Schools. A referral can come from anyone in regards to bullying, i.e. a student, parent, teacher etc. Any bullying referral goes to the student and/or parent then to the counselor who turns it over to the administrators. Bullying is an intentional physical and/or emotional intrusion on a person's well-being and not be tolerated at any level. Investigate, notify, discipline and follow-up are the steps to take upon receiving a report of bullying.
